Subsequently, the Institute had published the list of Provisionally Shortlisted and Not-Shortlisted applicants for the said post. In this regard, the applicants were given an opportunity to submit representations, if any, against their non-shortlisting, along with supporting documents, within the stipulated schedule.

Within the prescribed schedule, a total of 15 (fifteen) representations were received from the applicants. The Scrutiny Committee has scrutinized and verified all the representations and the documents submitted in support thereof, in light of the prescribed essential educational qualification/experience and the "GENERAL INSTRUCTIONS AND OTHER TERMS & CONDITIONS" of the advertisement.

After due consideration of the representations and supporting documents, the Scrutiny Committee has recommended 01 (one) additional applicant, against Application No. IISER-K/NT/1364, for provisional shortlisting for the post of Assistant Registrar. The reason for not shortlisting is given in **Annexure – I**.

Accordingly, the total number of Provisionally Shortlisted applicants stands revised from 17 to 18.

The revised and final status of the applicants, indicating the Application No. only, is attached herewith in **Annexure – II** for information of all concerned.
